

RiverNorth Opportunities Fund, Inc.

*Statement Pursuant to Section 19(a)
of the Investment Company Act of 1940*

On July 26, 2017, the RiverNorth Opportunities Fund, Inc. (the “Fund”) paid a distribution of \$0.14 per share to shareholders of record at the close of business on July 17, 2017. In accordance with generally accepted accounting principles (“GAAP”), the Fund estimates that 25.72% of that distribution is attributable to current fiscal year net investment income and 74.28% is attributable to realized short-term capital gains.

The timing and character of distributions for federal income tax purposes are determined in accordance with income tax regulations which may differ from GAAP. As such, all or a portion of this distribution may be reportable as taxable income on your 2017 federal income tax return. The final tax character of any distribution declared in 2017 will be determined in January 2018 and reported to you on IRS Form 1099-DIV.
